**Mirizio and Fischle Repeat Wins**

**MIRIZIO DEFEATS STERNBERG IN RACE #3, FISCHLE BEATS FERRE TO WIN RACE #4 AND MAINTAIN POINTS LEAD**

The Auto Club Dragway at California Speedway, (June 6th & 7th)- Driving his M&M Metals-backed dragster, Bobby Mirizio took home his second K&N Super Eliminator Series trophy by defeating Todd Sternberg in the final of Race #3, and Eddie Fischle continued his hot streak by winning race #4 when Cameron Ferre's dragster lost a connecting rod in the final round.



In Saturday's race, sponsored by **Jones Apartment Management of Austin, TX**, Mirizio began his march to the final when Cathy Means red-lighted in the first round, Eddie Fischle

red-lighted in the second round, then used a perfect reaction time to overcome **Clay Smith #1 Qualifier Award** winner Pat Welch's 7.908 in the semi-final. On the other side of the ladder, Todd Sternberg, driving Lenny Diycio's car, put away Pat Jones and Tom Dufur, then drew the competition bye in the semis. Sternberg had the better light by .006, but Mirizio's 7.914 gave him a .002 MOV over Sternberg's 7.922. As the defending race winner from the previous race, Mirizio fought off all challengers to claim the **Salt Creek Grille "Trash the Champ" award** of a \$100 dining certificate by winning back-to-back events, and he received the **Clay Smith Engineering** winner's bonus in addition to \$1000 for the win.

In Sunday's race, sponsored by **Burkhalter Pool Plastering**, **Clay Smith #1 Qualifier** Fischle began his march to the final with a win over Means, then took out Mirizio in the second round to earn the **Salt Creek Grille "Trash the Champ" award**, and drew a bye in the semis. On the other side, Ferre took out Dave Kembrowski, Welch, and Chris Diycio to set-up the final. Ferre had an excellent .006 light at the green, but trouble soon began as his engine suffered a broken connecting rod, allowing Fischle to easily drive around for the victory. Fischle received over \$1000 for the win plus the **Clay Smith Engineering** winner's bonus.

The **JE Pistons 7.90 Club \$50 gift certificates** went to Cathy Means on Saturday, who was the closest first round loser to the 7.90 index with a 7.941, and to Tom Dufur on Sunday for his 7.905.
