Fischle and Mirizio Win Season Openers

FISCHLE DEFEATS MCNICOL IN RACE #1, SE ROOKIE MIRIZIO BEATS #1 QUALIFIER WELCH TO WIN RACE #2

The Auto Club Dragway at California Speedway, (May 23rd & 24th)- Driving his Lucas Oil-backed dragster, Eddie Fischle took home the coveted K&N Super Eliminator Series trophy by defeating Chris McNicol in the final of Race #1, and two first time Super E competitors met in the final of race #2 with Bobby Mirizio taking the win over Pat Welch.



In Saturday's race, sponsored by **Parcorp Stainless Steel**, Fischle took out dad Tracy Fischle in the first round, then overcame Lenny Diyco and Pat Jones to face Chris McNicol in the final. Returning to Super E competition for the first time in several years, McNicol overcame race sponsor Kenny Upton, **Clay Smith #1 Qualifier Award** winner Chris Diyco, and drew a third round bye to set up the final with Fischle. Fischle had the advantage in the final round with a .008 better light and drove to a stellar 7.909 to push out McNicol with a 7.889. As the defending race winner from the last race in the 2008 season, Fischle fought off all challengers to claim the **Salt Creek Grille "Trash the Champ" award** of a \$100 dining certificate by winning back-to-back events, and he received the **Clay Smith Engineering** winner's bonus in addition to over \$1000 for the win.

In Sunday's race, sponsored by **Hahn International Custom Brokers**, Mirizio began his march to the final with a win over Chris Diyco, a bye in the second round, and a victory over Tracy Fischle to set up the final round match-up with his good friend Pat Welch. Welch earned the **Clay Smith #1 Qualifier Award** and a first round bye, then defeated Jones and Eddie Fischle to earn a berth in the final. Mirizio took the starting line advantage by .014 and held on for the win with a 7.918 to Welch's break-out 7.889. Welch also received the **Salt Creek Grille "Trash the Champ" award** when he defeated previous race winner Eddie Fischle in the semi-finals. Mirizio received over \$1000 for the win plus the **Clay Smith Engineering** winner's bonus.

The **JE Pistons 7.90 Club \$50 gift certificates** went to Tom Dufur on Saturday, who was the closest first round loser to the 7.90 index with a 7.915, and to Dave Kembrowski on Sunday for his 8.005.
