Kinard and McNicol Nab Wins

KINARD DEFEATS MEZIERE, MCNICOL BEATS NEWTON, FISCHLE MAINTAINS POINTS LEAD INTO FINAL WEEKEND

The Auto Club Dragway at California Speedway, (July 4th & 5th)- Driving his PB B'laster-backed dragster, Aaron Kinard took home the coveted K&N Super Eliminator Series trophy by defeating Don Meziere in the final of Race #5, and Super E veteran Chris McNicol took the win over Josh Newton in Race #6.

In Saturday's race, sponsored by Means Financial Services, Kinard took out race sponsor Cathy Means in the first round, then overcame Shannon Chennault and Tracy Fischle to face Meziere in the final. Meziere overcame Tom Dufur, Pat Jones, and Clay Smith Engineering #1 Qualifier McNicol to set up the final with Kinard. In the final, Meziere had the advantage at the green with a .007 reaction time to Kinard's .013, but Kinard's 7.891 was good for the win over Meziere's quicker 7.869. Kinard received the Clay Smith Engineering winner's bonus in addition to over \$1000 for the win. Jones claim the Salt Creek Grille "Trash the Champ" award of a \$100 dining certificate when he defeated previous race winner Eddie Fischle in the first round.

In Sunday's race, sponsored by Probe Pistons, McNicol began his march to the final with wins over Means and Chennault, and defeated Kinard in the third round to claim the Salt Creek Grille "Trash the Champ Award" and set up the final round match-up with Newton. Newton defeated Dufur, Clay Smith Engineering #1 Qualifier Meziere, and drew a bye in the semi-final round to earn a berth in the final. Newton took the starting line advantage by .014, but was the worse offender in the double break-out final, 7.887 to McNicol's winning 7.896. McNicol received over \$1000 for the win plus the Clay Smith Engineering winner's bonus. The JE Pistons 7.90 Club \$50 gift certificates went to Team Owens, headed by NHRA's own Harold Owens, on both days. They were the closest first round losers to the 7.90 index, posting a 7.931 on Saturday and a stellar but losing 7.900 on Sunday. The next two K&N Super Eliminator Series races will be the series finals on October 24th and 25th at the Auto Club Dragway at Fontana, California.
