## Sternberg Wins Race #2, Spiegel Holds on to Points Lead

The Auto Club Dragway at California Speedway, (May 19th & 20th)- 19 cars showed up to do battle in the second So Cal Super Eliminator race of 2007, which featured an all Team Diyco final as Todd Sternberg, driving Lennie Diyco's dragster, won the event over a red-lighting Chris Diyco. This special **Larry Winter Tribute and Race** was sponsored by **Vaughn Investments**, with qualifying on Saturday and eliminations on Sunday. Saturday evening was a Larry Winter Tribute barbecue, with about 100 racers, friends and family there to honor our Special Guest Larry Winter, who was injured in a racing incident several years ago. The barbecue was generously supplied by **Steve Williams of K&N**, with additional help and supplies from the **Larry Winter family, the Kenny Upton family, Starfighter Motorsports, and Burkhalter Pool Plastering**. The **Clay Smith #1 Qualifier Award** of a \$100 gift certificate went to Jeff Derencin, whose dad is Jack Derencin, President of the Super Comp Association. Jeff went 7.907 to lead the pack; not bad for an 8.90 guy! The **JE Pistons Random One \$100 gift certificate** went to #12 qualifier Mark Engle.

In the first round, Chris Diyco defeated a red-lighting Dennis Peterson, Shane Turner advanced over Chuck Swift who broke out with a 7.867 to Turner's 7.914, Brian Schroepfer ran a 7.911 to beat Shawn Drake's 8.029, Cameron Feerer' used an .010 light and 7.937 to defeat Harold Owen's better .009 light and slower 7.995, Kenny Upton singled to victory with a 7.891 when Mark Engle broke on the last qualifying pass, defending champ Andy Spiegel put together a great .007/7.903 pass to defeat Tom Dufur's .003/7.881 driving the Team Dufur/Dessinger entry, and Randolph Scott overcame Pat Jones who had mechanical difficulties, 8.386 to 8.395. Todd Sternberg started his march to the final with a great .002 light to earn the **Starfighter Motorsports "Who Got the Light?" award** of 5 gallons of racing fuel, beating Justin Davis who red lighted, and Aaron Kinard was lucky enough to advance with a -.008 light and a break-out 7.850 pass when his opponent, Guy Johnson, went even deeper into the red zone with a -.040 light and 7.945 e.t. Number one qualifier Jeff Derencin advanced with a competition single, running 7.913 to let everyone know that he was here to play.

In the second round, it was Chris Diyco over a red lighting Schroepfer, Upton over a red lighting Scott, Spiegel with another impressive .007 reaction time over Turner, Sternberg over a breaking out Kinard, 7.918 to a 7.894, and Derencin over Feerer' in a very close double break out race, Derencin's .009/7.897 to Feerer's .005/7.896. Third round action had Sternberg advancing over Upton when Kenny went slightly red with a -.002 to Todd's 7.907 e.t., Spiegel beat Derencin with another good light, .013, coupled with a 7.925 to obviate Derencin's fine 7.903 with a .036 light. Diyco ran a 7.879 in a bye run.

In the semi-finals, Diyco stopped Spiegel's reign of terror (10 consecutive round wins in the last 3 races!) with a great .010 light and 7.903 to Andy's .026 and break out 7.896, and Sternberg got a single with the Lennie Diyco-owned dragster to set up an all-Diyco clan final. The race was over before it started for Chris, as he drew the big red eye with a -.008 while Sternberg drove it out to a fine .012-initiated 7.915 to take his second career So Cal Super Eliminator win.

In honor of Larry Winter, **Steve Williams from K&N and Kenny Upton from Parcorp** generously added \$400 each to the winner's purse, bringing Sternberg's winner's check up to \$2,050 plus a **Clay Smith Engineering** \$50 gift certificate and \$200 in contingency awards from **Edelbrock**. On his way to the final round, Diyco collected the **Salt Creek Grille "Trash the Champ" award** of a \$100 dining certificate by beating Andy Spiegel, the previous race winner. After the first two

races, Spiegel is leading the points chase with 148 points, followed by Kenny Upton, Team Lennie Diyco/Todd Sternberg, Pat Jones, and Chris Diyco.
